## **ALASKA USA FEDERAL CREDIT UNION ULTRABRANCH SERVICE AGREEMENT**

Use of UltraBranch shall be governed by the terms and conditions applicable to Subscriber's account(s); the following terms of this Agreement; bylaws, rules, regulations, or applicable law; and such other terms, conditions, and/or amendments as may be established from time to time and communicated to Subscriber in writing. Use of UltraBranch Bill Pay is governed by the terms and conditions of that specific service.

1. A secret PAC will be issued exclusively to Subscriber by Alaska USA Federal Credit Union (Alaska USA). Subscriber agrees to promptly change the PAC issued by Alaska USA to one of Subscriber's choosing and agrees to make every reasonable effort to protect the security of his/her PAC to ensure that the PAC is not obtained by another person. Subscriber agrees to be responsible for all transactions performed by anyone to whom Subscriber has provided his/her PAC.
2. Subscriber may use UltraBranch to access account and credit union information, transfer funds between accounts, withdraw funds by mailed check, and perform other financial services that may be offered and announced from time to time. Transactions will be posted to the account(s) and IDs designated by Subscriber and will appear on Subscriber's periodic statement(s) of account. Subscriber agrees to immediately pay any overdrawn amounts without notice or demand and, if in default, all related collection costs and attorney fees.
3. Subscriber shall review statements of account from Alaska USA promptly and report any errors or unauthorized transactions. The Federal Electronic Funds Transfer Act Disclosure, which will be provided separately to Subscriber, specifies the legal limitations on Subscriber's liability for unauthorized transactions, as well as the rules for unauthorized transactions and error resolutions.
4. Alaska USA retains the right to limit the frequency and duration of access to UltraBranch service or any function thereof, limit the amount of withdrawals, assess fees, or change its policies regarding these matters at any time without amending this Agreement. Subscriber's account(s) may be debited for such fees. Current limits and fees, if any, will be provided to Subscriber separately in writing. UltraBranch service may be revoked by Alaska USA without notice.
5. Alaska USA makes no claims or warranties with respect to the operation of the associated equipment or system(s), and shall not be liable for any equipment failure or malfunction of the equipment or system(s), except as provided by law.
6. Subscriber may cancel this Agreement at any time by notifying Alaska USA verbally or in writing. In that event, all rights and obligations for any transaction that occurs before Alaska USA received notice of cancellation shall be determined by this Agreement.
